- \$300 MINIMUM RETAINER - \$60 / HR AFTER FIRST 2 HRS (Based on typical a case involving one questioned signature, the initial retainer usually covers the examination and verbal report. More signatures and/or especially complicated cases may result in additional hourly fees. Any charges beyond the retainer are due upon delivery of report.)
